

LARRY McKNIGHT (VE3 ASB) - A PROFILE BY LARRY (ASB)

HELLO, BY WAY OF SHOWING YOU WHAT I EXPECT TO DEVELOP FROM THE INTERVIEWS THAT I CONDUCT IN THE FUTURE, I THOUGHT IT APPROPRIATE TO DO A PROFILE ON MYSELF FIRST.

MY INTEREST IN HAM RADIO GOES BACK A LONG WAY, IN EACT, ALL THE WAY TO PEITITCODIAC (A HALF FRENCH, HALF INDIAN NAME MEANING LITTLE RIVER) A LITTLE TOWN OUTSIDE OF MONCTON, N.B. I WAS INTERESTED IN RADIO AS EARLY AS SIX YEARS OF AGE, BUT, OF COURSE, AT THAT. AGE, IT HAD TO REMAIN JUST THAT... AN INTEREST. I BECAME AN AVID READER ON RADIO AND ELECTRONICS IN GENERAL AND WAS SOON MAKING POCKET MONEY OUT OF REPAIRING RADIOS (AND THE ODD T.V.). I MUST ADMIT THAT MOST OF THE REPAIRS CONSISTED OF REPLACING A TUBE OR TWO, BUT THAT, IN ITSELF TAUGHT ME A LOT. I MANAGED TO GATHER A LOT OF 'GOOD PARTS' DURING MY SCHOOL YEARS AND ALWAYS HAD A FEW DOLLARS FOR SATURDAY NIGHT ON THE TOWN!

I LEARNED THE MORSE CODE SEVERAL TIMES DURING THOSE YEARS BUT NEVER TRIED THE 'TEST'. GIRLS MAY HAVE DISTRACTED ME OR MAYBE LIFE IN GENERAL HELD MORE INTEREST AT THE TIME--I JUST NEVER GOT THERE. (MY CHOICE WOULD BE THE GIRLS- EDITOR)

AFTER FINISHING HIGH SCHOOL, I DECIDED TO SEE THE WORLD (ONTARIO) AND, THREE (3) JOBS AND SEVEN (7) YEARS LATER, I HAD THAT OUT OF MY SYSTEM AND SETTLED DOWN(?).

THE FIRST OF MY THREE JOBS WAS DOING HOUSE CALLS AS A (SURPRISE!!) TV REPAIRMAN BUT THE FINANCIAL RETURNS WERE NOT SUFFICIENT TO PAY MY BOARD SO THAT DIDN'T LAST LONG.

IN 1979, I PURCHASED A KENWOOD PORTABLE 2-METER RIG THINKING THAT OWNING IT WOULD BE THE 'KICK' REQUIRED TO MAKE ME GET MY 'TICKET'. DISMAL FAILURE--- I LISTENED FOR A YEAR (EVEN JOINED, TEMPORARILY, A HAM CLASS) BUT NO SOAP; PHOTOGRAPHY HAD TAKEN PRECEDENCE FOR A WHILE AND HAD EVEN DEVELOPED INTO A SMALL BUSINESS WHICH I CAREFULLY 'NURTURED' FOR ABOUT 4 YEARS.

IN 1981, I ACCEPTED A TRANSFER TO THE WILDS OF NORTHERN NEW BRUNSWICK AND, SINCE MY 'BUSINESS' DID NOT GO WITH ME, I SOLD MY TWO 'BIG' CAMERAS AND PACKED UP MY DARKROOM EQUIPMENT. TIME TO FIND A HOBBY THAT WOULD ALLOW ME TO SPEND TIME WITH MY FAMILY--HAM RADIO 'FILLED THE BILL'.

I DUG OUT THE KENWOOD AND DETERMINATION SET IN; GET A TICKET OR SELL THE RIG. I WAS SOON ONE HAPPY VEI(ASB) AND DEPLORING THE FACT THAT I HAD WASTED SO MANY YEARS.

NEXT, IT WAS BACK TO TORONTO AND WE CHOSE TO SETTLE IN THE AJAX AREA AND I JOINED BOTH THE NORTH SHORE AND THE SOUTH PICKERING AMATEUR RADIO CLUBS. THE DOC KINDLY ISSUED MY NEW CALL (VE'3'ASB) WHICH PLEASED ME AS I ONLY HAD TO CHANGE I CHARACTER IN MY CALL.

(EDITOR--- I APOLOGIZE TO LARRY FOR MAKING CHANGES TO HIS TEXT IN ORDER TO GET IT ALL ON ONE PAGE--I DON'T THINK I LOST ANY OF THE SENSE EXCEPT THAT I LEFT OUT HIS REMARK THAT HAVING BEEN FIRST 'INTERVIEWED' HE HAS DEMONSTRATED THAT THERE IS NOTHING FOR THE REST OF YOU TO FEAR WHEN HE ASKS YOU FOR AN INTERVIEW.)

ARE FUTURE HAMS CALLED PIGLETS OR HAMLETS?? (SUBMITTED BY RAY (OUB))

ON MARCH 11, FOUR OF OUR MEMBERS OPENED THE DOORS OF THEIR INNER SANCTUMS TO ALLOW A GROUP OF YOUNGSTERS A GLIMPSE OF THE WONDERS OF AMATEUR RADIO. THESE FOUR, GLEN (AEQ), RON (AIY), GARY (CNO) AND RAY (OUB) WERE A LITTLE PERTURBED WHEN, AFTER PREPARING FOR A GROUP REPORTED TO BE BETWEEN THE AGES OF SEVEN AND FOURTEEN, THEY FOUND THEIR GUESTS WERE MOSTLY IN THE SEVEN YEAR OLD CATEGORY AND WERE ACCOMPANIED, AS IS PROPER, BY ADULTS WHO APPEARED TO BE AS INTERESTED AS THE YOUNG ONES. RAY INDICATED THAT THE OTHER GROUPS FARED A LITTLE BETTER WITH GLEN HAVNG QUIETER GROUP AND THE OTHER TWO RESORTING TO ATV WHERE THE KIDS COULD REALLY HAVE FUN MAKING FACES AT EACH OTHER (HI HI DE RAY).

RAY SAYS HE ENJOYED EVERY MINUTE (I ALWAYS SAID HAMS SHOULD HAVE THEIR HEADS READ-EDITOR) THEY WERE GRACIOUSLY THANKED AND THE ADULTS INDICATED THEY WOULD ENJOY AN ENCORE BUT EVEN THEY SUGGESTED A SLIGHTLY OLDER GROUP. I'M SURE THAT THE OTHERS ECHO RAY'S ENJOYMENT AND WE ALL HOPE THAT SOMEDAY ONE OF THE BOYS THAT VISITED OUR MEMBERS ON THE 11TH OF MARCH WILL DISPLAY HIS HAM SHACK TO ONE OF OUR SONS OR GRANDSONS.

LET'S PRICE THEM AT THE 'WHAT IS IT ACTUALLY WORTH TO ME' NOT THE 'HOW MUCH CAN I GET OUT OF IT' APPROACH.

IT WOULD ALSO BE NICE IF WE COULD HAVE A SMALL GROUP OF VOLUNTEERS WHO WOULD BE WILLING TO HELP THE PURCHASER MAKE ANY NECESSARY REPAIRS (HERE I WOULD ASSUME THAT THE VENDER HAS ALREADY TOLD THE PURCHASER EXACTLY WHAT WAS WRONG WITH IT) AGAIN, I WOULD STRESS THE HELP SHOULD BE ADVISORY ONLY.

SCORING:

Each phone contact with a member counts 2 points; each CW contact with a member counts 5 points. In addition, members will receive 1 point for each non-member contact on phone, 2 on CW. ALL CONTESTANTS receive one 10-point bonus for each CLARA FAMILY MEMBER worked.

For FINAL SCORE multiply BASE SCORE by number of Canadian provinces and territories worked (12 possible).

Highest-scoring member - trophy

Highest-scoring non-member - trophy

Highest score from each DX country - certificate

Highest score from an SWL - certificate

A special prize will be awarded to the CLARA family member whose callsign appears most often in logs submitted, whether or not that family member has actually entered the contest.
