HAVE YOU EVER WONDERED?

The following was researched and written by Mary Drummond (VE3IYY), a former member of the P.A.R.C. (now a silent key) and was printed in their bulletin of August 1984.

Have you ever wondered why amateur radio operators are called 'HAMS'?

The word 'HAM' was applied in 1908 and was used as the call letters of one of the first amateur wireless stations, which was operated by some members of the Harvard Radio Club. Their names were Elbert S. Hyman, Bob Almy and Peggy Murray.

At first they called their station 'Hyman-Almy-Murray'. Typing out such a long name in code soon called for a revision and they shortened it to 'Hy-Al-Mu' using the first two letters of each name.

Early in 1909, some confusion resulted between amateur wireless HYALMU and a mexican ship named HYALMO, so they decided to use only the first letter of each name. Thus the call became 'HAM'.

In the early pioneer, unregulated days of radio, amateur operators picked their own frequency and call letters. Then, as now, some amateurs had better signals than some commercial stations. The resulting interferences finally came to the attention of congressional committees in Washington. They gave much time to proposed legislation to critically limit amateur activity.

In 1911. Elbert Hyman chose the controversial Wireless Regulation Bill as the topic for his thesis at Harvard. His instructor insisted that a copy be sent to Senator David I. Walsh, a member of one of the committees hearing the bill. The senator was so impressed that he sent for Hyman to appear before the committee. He was put on the stand and described how the little amateur station was built and he almost cried as he told the crowded committee room that, if the bill was passed, they would have to close up the station because they could not afford the license fees and all the other requirements which were set up in the bill.

The debate started and the little station 'HAM' became a symbol of all the little amateur stations in the country who were crying out to be saved from the big commercial stations who didn't want them around. Finally, the bill got to the floor of Congress and every speaker talked about the poor little station 'HAM'.

The whole story is contained in the Congressional Record of the USA. Nation-wide publicity associated 'HAM' with amateurs and from that day to this (and hopefully to the end of time), an amateur is a 'HAM'.

HAVE YOU EVER HEARD OF 'FLEA MARKETS'

I am sure you are all aware of them and that they don't sell fleas. I am also sure that you are aware of the joint venture between the S.P.A.R.C. and the N.S.A.R.C., 'THE DURHAM REGION AMATEUR RADIO FLEA MARKET' which occurs every April.

This year our club coordinator will be Gord McCuaig (VE3NZS) who will be assisted by John Pluister (VE3FGL) assisted by us all. It is well to remember that this endeavour is what amateur radio is really all about (amateurs helping amateurs). The flea market brings together new amateurs who need equipment and people (mostly amateurs) who have equipment to sell. It also helps both clubs to up-date club services and equipment (our new controller is a good example), so when contacted to help, please say "YES!". You won't regret it!!!

I have been plagued for over a year now by "noise" on all the H.F. bands (80 - 10), and the lower the band, the higher the level of noise. This "noise" is evident all across the band, is there at any time of the day or night, and does not seem to vary with weather conditions.

With the very much appreciated help of Eric HMG. (who is a whiz at locating noise sources), I have been able to enlist the help of John Sanderson and relay the locations of at least three possible sources.

John Sanderson is the Engineer at the Whitby Hydro-Electric office, who not only enthusiastically followed up on this information, he also has called the D.O.C and has had the inspector in this area on a number of occasions.


I must say, it was quite interesting to go out with the inspector, who incidentally is a ham, in his fully equipped vehicle, and with credit to Eric, located the same problem areas.

If any one has the time and can go portable with H.F. in this area to check it out, I will be grateful or if there is some one who is experiencing the same problem ,perhaps they would call me and let me know.

DON'T THROW IT AWAY

If anyone reading this has a ball-point pen with a digital watch and calendar built into it and the display has dimmed and/or finally disappeared, then had trouble finding batteries for it, despair not; all is not lost! Jack (VE3SJ) knows what to look for.

Jack points out that the battery used is an Enercell 23-146A mercury battery commonly used in hearing aids and can be picked up at 'Radio Shack'; stock number 23-146-590315812. They come in a 'six-pack' for \$4.99 and usually last about 1 year ea.

Jack, himself, prefers to use a Duracell RM414 which can also be purchased in a 'six-pack' at Guardian Drugs (stock number 412-015-205R-J5) for a price of 6.14. These batteries are the same diameter but thicker and last over twice as long.

Jack reports that these watches keep excellent time, have a BIG cartridge and write well so he suggests that if you have one not to hesitate to replace the battery. (I have one of them in this condition but I think it would be cheaper to buy a new pen unless I can find 5 more to use up the extra batteries——I'm sure to lose the pen before two more years is up. ed.)


